MINUTES

1. Call to Order (Including a roll call):

GAATN Technical Subcommittee Chairman Jaime Guerra called the meeting to order at 1:30 p.m.

- 2. Citizen Communications: There were no citizen communications.
- 3. Review and approve minutes from the regular Technical Subcommittee meeting of November 14, 2023

 Dain Herbat moved to approve the draft minutes as presented; Gary Weseman seconded the motion and it passed unanimously.

4. Maintenance Contractor's Report

A. Maintenance report

Chris reported that, since the previous meeting, the maintenance contractor has completed inspections on A1N, A2N, SRN and SRS; there were 24 corrected deficiencies between the four rings. Chris said there was nothing out of the ordinary to report. Jaime asked about pending pole transfers; Chris said there are many pending transfers on all rings. Jaime asked how they are notified when it's GAATN's turn to complete their pole transfer; Chris said it's a combination of getting an NJUNS ticket as well as catching it on routine ring inspections.

B. Inventory report

Chris said there were no changes to this report since the previous meeting.

5. Network Manager's Report

A. Project status report

Carlos reported on the following upcoming and recently completed projects:

- UT B1N/C1N JJ Pickle node redundancy install completed 12/4/23

B. Network status report

Carlos reviewed the following incidents that occurred on the network since the previous meeting:

- 12/18/23 SRN 7901 Cameron Road COA node cable torn down by unknown truck (only COA affected) BryComm performed an emergency repair (COA specific repair)
- 12/6/23 D1N Harold Court #2 cable cut vandalism (all entities affected) BryComm used existing slack to perform an emergency repair.

Sarah reviewed the new report format and discussed the incident trends over the last two years.

C. Job budget report

Sarah reported that management is tracking 45 jobs totaling \$3.0 million. So far for FY24, 12 jobs have been completed and \$430k has been invoiced. That leaves \$2.68 million encumbered for the remaining 33 jobs. GAATN has recovered \$161k in damage claims and project reimbursements for FY24. The fund balance bottom line is \$1.08 million.

6. Committee Chairperson's Update – discussion and possible action on:

A. Seeking recommendation for COA SRS new node site Capital Area Council of Governments (CAPCOG)

This agenda item was discussed in executive session under Texas Government Codes 418.181 and 551.089. Upon reconvening in open session, Jaime Guerra moved to recommend for Board approval the COA SRS new node site at Capital Area Council of Governments (CAPCOG); Dain Herbat seconded the motion and it passed unanimously.

B. GAATN fiber segment aging report and recommendations

Carlos reviewed a report showing the oldest fiber segments on the GAATN network and discussed which ones are already approved for replacement. SRN has the most footage of 25+ year old fiber, however SRS is the current priority project. Jaime noted that SRN was further down on the priority list. Dain said that the priority list was based on each entity's priorities and SRS is Travis County's priority. Carlos noted that the aged fiber has survived the major cold snaps over the past few years. There was no action taken on this agenda item.

C. Austin ISD 2022 Bond Projects Impact to GAATN Super node Sites (Travis HS, Northeast ECHS, and Crockett HS)

Paul said the only update for this project at Travis High School is that they are currently waiting on pre-fabricating building pricing. He noted that the pre-fabricated building is a turnkey solution and includes racks. Carlos asked him to send management that information so it can be shared with the NOCC subcommittee.

D. Backup NOCC Decommissioning

Carlos reported that everything is moving along with the decommissioning and there is nothing further to report at this time.

E. Backup NOCC Relocation and Subcommittee Update

Carlos reported that the NOCC subcommittee met yesterday and reviewed some prints and a room design. He said GAATN is waiting on the fire department to respond about any additional approvals that are needed regarding the location. The remainder of this agenda item was discussed in executive session under Texas Government Codes 418.181 and 551.089. Upon reconvening in open session, there was no additional discussion held or action taken.
